

NSW ELECTION GUIDE 2019

The NSW State Election will take place on Saturday 23 March. It is important that we all cast our vote in accordance with our conscience, informed by a profound respect for the dignity of the human person, from conception until natural death, and for the common good of the community.

The next term of the NSW Parliament will confront serious issues including religious freedom, abortion and euthanasia, education and homelessness, and we need to exercise our vote with a mind to which persons and parties might best respond to these important matters. The major and minor parties were asked to respond to a series of questions about the parties' stance on some of the most critical issues at stake in this election.

This year, we invited minor parties to provide responses as well, because recent history has shown the difference that a single vote or small number of votes can make when legislation about key social issues is put before parliament. In NSW, a bill that would have allowed euthanasia was defeated in the NSW Upper House by a single vote, and at a federal level, a bill that would have paved the way for euthanasia in the territories was defeated by just two votes. It is important to carefully and separately consider your vote in each House of Parliament, and this guide may assist you in making those choices.

Let us continue to pray for our leaders, for all men and women called to public service, and for our fellow citizens as they approach the coming election, that they may exercise their vote with respect for the dignity of the human person and for the common good of the state.
