Earlier this week, the *Reproductive Health Care Reform Bill 2019 (Bill)* passed the NSW Lower House.

It will now proceed to the NSW Upper House for a vote and, if passed, it will make abortion legal up until birth in NSW, for any reason, as long as two doctors agree if the baby is more than 22 weeks' old.

The Bill has been rushed through Parliament, but there is still time for your voice to be heard in this debate.

**We must act immediately to try and stop this Bill.**
